NOTES										
1	A case can only be included as low level in these instances where abusive language is not present: In the event of any breach of Rule E 3(1) including a reference to any one or more of a person's ethnic origin, colour, race, nationality, faith, gender, sexual orientation or disability (an "aggravating factor") (resulting in an E3(2) charge), a Commission shall impose an increased sanction as outlined below. In all cases where an aggravating factor exists, the minimum sanction of 5 matches and £75 fine must be imposed. For a first offence, a sanction that is double that which the Regulatory Commission would have applied had the aggravating factor not been present. For a second offence, a sanction that is treble that which the Regulatory Commission would have applied had the aggravating factor not been present. Any further such offence(s) shall give rise to consideration of a permanent suspension.

3	In such circumstances that the offence relates to playing whilst under suspension, the sanction imposed must be in addition to the number of matches the player participated in whilst under suspension.
